The 2020 Pedal Pilgrimage is a 23 mile bike tour along country roads and trails stopping at Richmond, Jacobs Prairie, Rockville and back to Cold Spring. Minors must be accompanied by an adult. While the prayer during the pilgrimage will be in a Roman Catholic style, the pilgrimage is open to people of all faith traditions.
